

CALLING FOR EXPRESSIONS OF INTEREST

FOR PURCHASE / PROCESSING OF CARBON DIOXIDE

Expression of Interest (EoI) is hereby invited from interested parties for outright purchase / processing of Carbon Dioxide Gas produced in the Ammonia Plant of the Fertilisers and Chemicals Travancore Limited(FACT) at Udyogamandal, Kochi, Kerala. The quantity of carbon dioxide available will be approximately 40 Tons per hour.

1.0 EoI's are invited for two options:

- i. Outright purchase of the CO₂ gas, to be made available by FACT at plant battery limits, at a pressure of 0.2 Kg/cm².
- ii. Setting up a plant for processing of CO₂ gas in land to be provided by FACT.

In option 2 the conditions applicable shall be as follows:

- FACT will consider providing land to the extent of 3 to 4 acres for setting up the processing facility on long term lease basis. The party shall install the plant and shall operate the facility. The land will continue to be owned by FACT and the party will have no right to use the land for any other purpose.
- Upfront payment and lease rent for the land shall be paid by the party to FACT as per terms and conditions to be finalized
- FACT shall supply carbon dioxide to the party based on a price formulae to be discussed and finalized

The party shall be responsible for obtaining all statutory approvals for setting up the plant but FACT will provide support as seen essential.

FACT is also open to discussions on any other business model suggested by the interested party for proceeding with the sales/processing of carbon dioxide.

2.0 Quantity: The quantity of CO₂ normally available for sale / processing will be around 960 MT per day or 3 Lakh MT per annum. However, in case of either option, if due to production interruptions or changes in production plan, the total availability of CO₂ is less than the total requirement of all buyers including existing buyers, FACT shall, at its sole discretion, allocate the available quantity among all buyers. In case of supply shortfalls due to whatever reason, FACT will not be liable for payment of any damages to the party.

3.0 Quality: The party shall get himself satisfied as to the quality of the gas. Normally the gas is made available with 95% purity, but FACT undertakes no responsibility for the purity or fitness of the gas for the buyer's use.

4.0 Period of Contract: The period of contract in case of either option will be for a period of 20 years, extendable on mutual consent and terms as applicable.

5.0 Response to EOI

Interested firms are invited to furnish proposal for EOI with following details:

- 1) Letter of submission of proposal.
- 2) Organization profile/ information about organization, organization structure, etc.
- 3) Technical & Financial capability of the organization with audited accounts/reports.
- 4) Proposed business plan
