1. FACT PROFILE:

4. ELIGIBILITY

The offer shall be considered only from Indian, technically competent, experienced parties who meet the following pre-qualification criteria:

5. SCOPE OF SERVICES

The Company intends to engage a consultant to provide advisory services to the Company for Accounting and finalisation of Financial Statements for the Financial year 2017-18, under the Indian Accounting Standards (Ind AS).

Ministry of Corporate Affairs (MCA) of Govt. of India, vide notification dated 16th February, 2015 has announced The Companies (Indian Accounting Standards) Rules, 2015. The said rules cast an obligation upon The Fertilisers & Chemicals Travancore Limited (FACT) for preparation and audit of the financial statements in full compliance with the notified Indian Accounting Standards (Ind AS) for the Financial Year 2017-18, along with comparatives for FY 2016-17.

The Company needs assistance from an experienced and competent consultant for conversion/preparation of Ind AS Compliant financial statements.

Detailed Scope of Work:

- i. Advise and assist in identification of differences between the current accounting policies, systems and practices of the Company and the requirements of the Indian Accounting Standards (Ind AS)
- ii. Submit a report on the necessary changes/modifications to be made in the Company Accounting policies/practices to comply with the Ind AS.
- iii. Advise and Assist in selection of Accounting Policies
- iv. Advice and Assist in preparation of the standalone and consolidated Financial Statements for the Financial Year 2017-18, along with comparatives for Financial Year 2016-17.
- v. Assist in Reconciliation between Ind AS and Indian GAAP
- vi. Advise and assist in meeting disclosure requirements.

6. INSTRUCTION TO BIDDERS

FACT reserves the right to accept or reject any tender including the lowest one in part of full, without assigning any reason whatsoever.

The offer shall have to be kept valid for a period of 60 days from the date of submission of tender.

7. CONTRACT PERIOD

- a) The contract shall be valid for a period of one month from the Zero LoI. But the consultant should support the Company for meeting the modification requirements and answering the related audit queries, if any for the next six months.
- b) FACT can terminate the contract at any time by giving 15 days prior notice to the contractor/service provider.

8. FEES

The professional fees to be quoted on lump sum basis. GST to be quoted extra.

The boarding & lodging including food, to the extent the facilities are available at the Company's guest houses shall be arranged & provided by Company at its cost.

No other out of Pocket Expenses shall be paid for the assignment, other than the quoted lump sum fees.

10. PAYMENT TERMS

Total of Professional fees as quoted plus the GST thereon at actual rate, shall be payable to the Consultant as follows: -

i. 50% of the quoted fees on submission of report on Ind AS applicability, as mentioned under item 5 (ii) of the Detailed Scope of Work.

ii. Balance 50% on completion of the Statutory Audit for the FY 2017-18 and signing/approval of the Financial Statements by the Board of Directors.

Invoice to be submitted on completion of the above milestones. The payment shall be made within 15 days following the date of receipt of invoice by the Company after deduction of tax at source as per applicable laws.

11. DELAY IN COMPLETION

13.1 The subject assignment must be completed by consultant with in the stipulated period. Time is the essence of this Order and Completion time agreed shall be binding. In event consultant is not able to execute the Order within the stipulated time limit, FACT will have a right either to cancel the Order without prejudice to any other rights to carry out the job from an alternate source at the cost of consultant.

12. TERMINATION

FACT reserves the right to terminate the Order in whole or in any part by serving 15 days written or fax notice to the Contractor at any time prior to completion of the contract period.
