1	As per the scope of work and BOQ given it is clear that it is a composite work with piping, civil and instrumentation jobs. Also, we have noticed that the IBR jobs involved in the total scope of work is comparatively small. We have previous experience in composite works but have no IBR license. All the criteria other than IBR certification for the above subjected tender will be qualified by us. So, we hereby request you to waive off the IBR requirement for the subjected tender so that we can also participate in the tender.	The IBR requirement shall be as specified in the Pre-Qualification Criteria (PQC).
2	The work is inclusive Civil works also. Approximately it may be about 25% of the total quantity of work. But Prequalification work order for participation in this bid, is instructed for Mechanical piping works only. As to our opinion pre-qualification may be considered inclusive of "Civil category works" also. So we humbly request the Company to take necessary steps. for pre-qualification criteria, by considering both category of works. (Civil and Mechanical Work Order).
