Sealed quotations are invited from the experienced, reputed and financially sound parties for supplying and fixing of FACADE (Board) at various dealer points in **Trivandrum District (38 Nos.) and Alappuzha District (44 Nos.) of South Kerala Zone (Total 82 Nos.) and Palakkad District (120 Nos.) in North Kerala Zone.**

1. Approximate number of FACADE (Board) required- 202 Nos. (approx.) in Kerala State.

Terms and Conditions:

1. The rates quoted should be for the item of work mentioned in the BID Form attached.
2. The rates quoted should be inclusive of all taxes and levies charged by the Govt. or any other agencies. The rates quoted will be valid for acceptance for a period of 6 months from the date of opening of the tender.
3. **The Zone wise quotation should reach the Deputy General Manager (Kerala State), FACT State Office, The FACT Ltd, Marketing Division, Old public relation building, Udyogamandal, Kochi – 683501, Ph- 0484-2567516 on or before 11 AM on 30.07.2024**
4. The quotations received within the stipulated time will be opened **at 2.00 PM on 30.07.2024, Tuesday at FACT State Office, Udyogamandal, Kochi.** The quotations received after the stipulated time and date will not be entertained.
5. The period of contract is for **one year from the date of award of contract.** The company reserves the right to accept or reject any or all quotations without assigning any reason what so ever.
6. The successful tender if awarded the contract should undertake the FAÇADE design & erection work at specified retail shops and allied works as per the design, specifications and guidelines of the company to the fullest satisfaction of the company.
7. The location of the dealer points and size specifications of the FAÇADE (Board) will be provided by the company with contact details of the retailers. The standard quality and installation should be used for making the FACADE (Board). **The FACADE (Board)** should be exactly in the size and specifications provided by the Company (The FACT Ltd).

8. The rates quoted by the successful bidder / Vendor is inclusive of all expenses to the transportation of FAÇADE (Board) and installation of the same at the specified retail counters in Trivandrum, Alappuzha and Palakkad districts.

9. The item of work includes the preliminary visit to the retail shops and taking measurements of the fitting size of PMKSK Façade banner & frame at the entrance of the shop, preparation of PMKSK Banner design for retailer (as per the standard design) and getting confirmation by the company officials before printing, transportation of the façade banner to the retail shops and erection, taking photos for proof of erection in Latitude & longitude photo app and submitting photos as the soft copy by what's app and mail to the company officials.

10. The successful bidder/Vendor should complete the work allotted as per the local requirement within the stipulated time and complete the work allotted within 3 months from the date of order given.

11. On completion of the work the contractor should submit the bills in duplicate. The contractor bills should accompany soft copy of the photograph of the work and a certificate from the concerned field officer of the company stating that the work has been completed as per the company's specification and to the satisfaction of the company.

12. The tenderer / bidder shall provide Earnest Money Deposit (EMD) of Rs.1000/- (Rupees One thousand only) by RTGS to FACT LIMITED through SBI, Udyogamandal Branch, Account Number 57017844467, IFSC SBIN0070158.

13. The Successful bidder will have to pay 3% of Work Order value as Security Deposit as per the Work Order immediately to start the facade erection work.

14. In the event of termination of the contract due to any fault/failure of the contractor the company reserves the right to make alternate arrangements for carrying out the work and to forfeit the security deposit / EMD of the contractor and adjust the loss/damage in the pending bills if any to make good the loss.

15. The company further reserves the right to realize compensation from him for additional loss if any incurred by the company as a result of contractor failure to fulfil his obligations as per the terms and conditions of the contract.

16. The dispute, show cause notice or penal action, loss/damage for the company for undertaking the work violating/deviating from the above, the contractor will be held responsible. FACT will not be responsible for any damage of board & charts during transportation and fixing.
