- 1. The rates quoted shall be exclusive of all taxes and levies charged by the Govt. or any other agencies.

- 3. The rates quoted shall be valid for 90 days from the date of tendering. The bidder shall quote rates for all the items on "as is where is" basis. Incomplete tenders will not be entertained.
- 4. GST, surcharge, duties, levies etc. shall be extra and shall be applicable on the quoted rate as per the prevailing rules of the Govt.
- 5. The items proposed for disposal are available for inspection during the office hours from 9 am to 5 pm from Monday to Friday except Sundays and Government holidays, till the last date and time for receipt of bids.
- 6. The company will award Sale Order to the successful bidder (H1) determined based on the highest total amount of the quoted values for each item as per the Bid Form attached.
