Call letter for Practical Test - Selection of Craftsman (Fitter cum Mechanic)

Further to the online test for selection to the post of **Craftsman** (**Fitter cum Mechanic**) in FACT, candidates are requested to appear at the time and date published in the website, at FACT Training School, Udyogamandal, Cochin for practical test and verification of documents (For updates, please check website www.fact.co.in >> Careers >> Results). Before appearing for the practical test, candidate must ensure themself that they fulfill the eligibility criteria as stipulated in the notification. Admission to the practical test does not imply meeting of eligibility criteria. Admission for practical test is provisional and is subject to detailed verification of documents / experience submitted by the candidate, which will be done only later.

Please note the following with respect to the relevancy of experience:

- 1. Only post qualification experience as on 01.01.2020 will be considered.
- 2. Experience shall be in the trade in a large Fertilizer / Chemical / Petrochemical Plant / Engineering Industry
- 3. Apprenticeship training in the relevant trade and specified industries only will be treated as experience on production of NAC.
- 4. Experience on part time basis, daily wages, experience in a firm which had undertaken contract work in the specified industries will not be considered.

While reporting for the above, candidate shall bring the following certificates in Original along with a self-attested copy of each. Originals will be returned after verification.

- a) Proof of Date of Birth.
- b) Proof of Qualifications (from Class X onwards)
- c) Caste / Community Certificate (applicable in the case of SC/OBC-NCL candidates) in the prescribed form available in this website, issued by a revenue officer not below the rank of Tahsildar.
- d) EWS Certificate issued by the Competent Authority for the relevant year ie; income for the year 2018-19. (Applicable in the case of EWS candidates).
- e) Ex-Service certificate as per the respective format prescribed by the government in original.
- f) Domicile Certificate.
- g) Valid Photo identity issued by Government Authorities.
- h) Proof of experience (Same as uploaded along with online application)
- i) NO OBJECTION CERTIFICATE from present employer if employed in Central/State Govt./PSUs/Autonomous bodies.



Candidate must bring the following also when you report for the practical test:

- a) Self-Attested copy of application submitted online against the above notification.
- b) The detailed Application Form uploaded in the website duly filled. Photographs shall be the same as used for the online application.

SC and PWBD candidates are eligible for II Class to and fro train fare in the shortest route from the present address (as provided in the application), as per rules, on production of documentary proof, subject to satisfying the eligibility conditions.

In case candidate fail to produce the original and self attested copies of certificates or do not meet the requirement of conditions specified like age, qualification, experience, caste, PWBD, ex-service certificate etc in the preliminary verification, candidate will be disqualified and will not be considered for further selection and the candidate will not be eligible for reimbursement of Traveling Expenses.

If offered appointment, it shall be subject to satisfaction of the conditions given in the notification for recruitment, including, but not limited to the following: Those employed in Central/State Govt. / PSUs / Autonomous bodies, shall furnish relieving order from the organization.

Please note that a candidate who had resigned/terminated from FACT is not eligible for recruitment.
