Candidates will be required to undergo pre-employment medical examination (PEME) and those being certified fit by Chief Medical Officer of the Company after PEME, will only be offered appointment. A candidate who is found medically unfit will not be appointed. Offers of appointment will be issued to candidates from General and Reserved Merit lists based on requirement (s), as per prevalent reservation rules and criteria given in the notification.
- 5. Appointment will be subject to verification of Character and Antecedents.

- 7.
