1. Names of candidates provisionally selected for inclusion in the Panels for the post of **Technician (Process) on Fixed Tenure Contract (Adhoc basis)**, ranked in the order of merit is notified hereunder.
2. Engagement from the panel will be based on requirements and subject to prevalent reservation rules and criteria given in the Notification. Engagement at any point of time will be entirely at the discretion of the Management. There is no assurance that all or any of the candidate(s) included in the panel will be engaged. Further, it will be subject to verification of documents in original such as Qualification, Age, Caste / Community, as applicable.
3. Candidates will be required to undergo pre-employment medical examination and those certified fit by the Company's Medical Officer will only be offered appointment. Originals of certificates along with other relevant documents called for shall be produced for the verification at the time of pre-employment medical examination. A candidate who is found medically unfit will not be engaged. Candidates offered engagement will be required to submit a Police Clearance Certificate. Candidates belonging to OBC-NCL, if engaged, shall submit OBC-NCL certificate issued within six months prior to date of joining.
4. A candidate who is already in employment as Technician (Process) on fixed tenure basis in the Company shall not be considered for appointment from the merit panel prepared under this notification, irrespective of their position in the panel, till they complete their maximum tenure of 4 years of their on-going engagement. Such candidates may be considered only against any future requirements after completion of such tenure, subject to reservation rules and validity of the merit panel, after completion of their existing tenure of 4 years of engagement.
