1. Names of candidates provisionally selected for inclusion in the Panel for the Post of Engineer (CIVIL) on Temporary contract basis for any projects in FACT/FEDO in Recruitment Notification No. 3/2025 dated 17.05.2025, ranked in the order of merit is notified hereunder.
2. Engagement from the panel will be based on requirements and subject to prevalent reservation rules and criteria given in the Notification. Engagement at any point of time will be entirely at the discretion of the Management. There is no assurance that all or any candidate(s) included in the panels will be engaged. Further, it will be subject to verification of documents in original such as Qualification, Experience, Age, Caste / Community etc, as applicable.
3. Candidates will be required to undergo pre-employment medical examination and those certified fit by the Company's Medical Officer will only be offered appointment. Originals of certificates along with other relevant documents called for shall be produced for the verification and shall submit Police Clearance Certificate at the time of pre-employment medical examination. A candidate who is found medically unfit will not be engaged. Candidates belonging to OBC-NCL, if engaged, shall submit OBC-NCL certificate issued within six months prior to date of joining.
4. As per cl. 14 of the notification, candidates who are already employed and being engaged in FACT as work charged employees in a particular project shall not be considered for appointment from a new merit panel, irrespective of their position in such merit panel. Such Candidates can only be considered against any requirements for which postings are to be made after the completion of their requirement in the existing project/job they have been already recruited for, and subject to reservation rules.
5. The panels will be valid for a period of one year from the date of this Merit Panel.
