Intimating Willingness for engagement in the order of priority of location

With reference to Merit Panel in Recruitment Notification No.10/2022 for the post of Clerk on Fixed Tenure Contract (Adhoc basis), for engagement in the Zonal Offices / Agro Service Centres (ASCs) at various locations of Marketing Division, in the States notified, candidates are advised to inform their willingness for engagement in the following establishments indicating the order of priority of interest, location wise.
