# Companywide Notification for Internal Candidates against the posts in Post Codes 1 to 14 of Recruitment Notification No.2/2024 dated 12.02.2024

- 1. Notification for recruitment to various posts in the Company, vide Recruitment Notification No. 2/2024 dated 12.02.2024 has been published in the newspaper and Company's website www.fact.co.in>> Careers>>Job Openings.
- 2. Employees on the permanent rolls of the Company who have been absorbed in scale of pay as on the "Relevant Date" mentioned Clause 6 of Notification No.2/2024, and who meet the specified qualification and experience for post codes 1 to 14 and conform to all other terms and conditions in the Notification No.2/2024, subject to relaxation to the extent mentioned below, may apply against the said posts :

Relaxation: Age shall be relaxed to the extent of actual period of service as a permanent employee in FACT, subject to maximum age of 53 years (after all relaxations applicable to Age in Recruitment Notification No.2/2024), as on the "Relevant Date" mentioned in Notification No.2/2024. Consolidated Pay period leading to permanent employment will be reckoned for this purpose.

- 2.1. All other relaxations as notified for external candidates in Notification No.2/2024 will be applicable.
- 2.2. Specified qualification (that conforms to Notification No. 2/2024 in all respects), if acquired while in service, shall be considered only if acquired with due permission from the Company.
- 3. Eligible applicants under this Notification will be considered along with external candidates against the open selection to the vacancies notified in the Notification No.2/2024.
- 4. Eligible applicants under this Notification are exempted from payment of Application Fee prescribed in Notification No. 2/2024. If a candidate who has availed such exemption from application fee is later found to be not eligible for such exemption, his/her application against notification No 2/2024, if any, will be treated as one where no application fee has been remitted, and eligibility decided accordingly. Therefore all candidates shall ascertain their eligibility before availing the exemption.
- Interested employees shall apply online against the Notification No. 2/2024 (Last Date 10.03.2024) and the print out of the application so submitted, along with the format attached to this notification, shall be forwarded by Registered Post to "Asst. General Manager (HR), HR Department, FEDO Building, Udyogamandal 683501, so as to reach on or before 20.03.2024.
