The Fertilisers and Chemicals Travancore Ltd. Udyogamandal, a Central Public Sector Undertaking, intends to form / update the list of contractors for carrying out the following categories of works up to Rs.10.00 lakh at its Udyogamandal Complex.

Terms and conditions

1.0 Grading of Contractors:

For specialised jobs, there will be only a single financial grading, i.e. up to the maximum limit of Rs 10.0 lakhs except for Electrical Specialised jobs under 4.a.

Above Rs 10 lakhs, open tenders are published in newspapers/website.

For General works and Electrical Specialised jobs under 4.a eligible contractors shall be graded as follows on the basis of their past performance, financial capability and value of work orders executed.

- 2.0 The parties who are already in the existing list of FACT UC shall furnish the details of major works done in UC/other Divisions of FACT/Other PSUs/private companies during the last 7 years.
- 3.0 Contractors who are registered with FACT- CD, FEW and other PSUs shall furnish the details and documentary evidence of their registration, group of work and grading, if any. They shall also furnish the details of major works done (in FACT / other PSUs / private companies) during the last 7 years.
- 4.0 Grading of those contractors who are already registered with FACT UC/other divisions of FACT/PSUs (2.0 and 3.0 above) shall be as follows:

For general works, those contractors who have not done any work in UC during the last 5 years / those who are not meeting the upgradation criteria will be retained in the list within grades in which their existing maximum limits are included. For such contractors, upgradation, if any, will be based on high value works done by them in other Divisions / PSUs/Private Companies as applicable to other non-registered contractors.

The criteria for upgrading other registered contractors shall be as follows:-

The existing registered contractors shall be upgraded to the next higher grade provided they have completed at least one work with value within the range of the next higher grade during the last 5 years.

They will also be considered for upgradation on the basis of high value works done by them in other Divisions / PSUs/ Private Companies as per the above criteria.

Registered contractors who have not responded to any of our NIT's for the last 5 years and those who are also not responding to the revision / upgradation notice shall be deleted from our list.

- 5.0 Following shall be the pre-qualification criteria for registration / grading of new contractors who are not registered with FACT / other PSUs.
 - a) Average annual financial turnover during the last 3 years, ending 31st March of previous financial year should be at least 30% of the upper limit of the respective grade.
 - b) Experience of having successfully completed similar works during the last 7 years ending last day of the month previous to the one in which applications are invited should be either of the following
 - 1) Three similar completed works each costing not less than the amount equal to 40% of the upper limit of the respective grade.

Or

2) Two similar completed works each costing not less than the amount equal to 50% of the upper limit of respective grade.

- 3) One similar completed work costing not less than the amount equal to 80% of the upper limit of respective grade.
- 6.0 Applicant shall list the categories for which registration is applied for.

- 8.0 The following documents shall be submitted along with the application for fresh registration.

 - iii) Copy of Annual Income Tax Return (for grading A & B only, i.e. Works above Rs 4 lakh)
 - iv) Solvency Certificate of minimum 80% of the upper limit of the proposed Grade from a Nationalised / Scheduled bank as on date of submission of application.
 - v) Banker's Certificate (Latest).
