1. Proof of Date of Birth. (Tenth class Certificate)
2. Proof of Educational Qualifications – Pass Certificate and Mark List of each Semester / Year as applicable from Class X onwards.
3. Experience Certificates to prove Experience as mentioned in the Online Application Form.
4. Apprenticeship Training – **Certificate of Proficiency (COP)** (Apprenticeship to be completed before the relevant date mentioned in the notification)
5. Caste /Community Certificate in the prescribed form up loaded in the website, issued by a Revenue Officer not below the rank of Tahsildar. 12. A self-attested print-out of the application submitted online against the notification under reference above.

Apprenticeship will not be considered as experience if the Certificate of Proficiency (COP) issued by Board of Apprenticeship Training is not produced at the time of document verification. In case candidates fail to produce the original certificates or do not meet any of the eligibility criteria as specified in the notification including age, qualification, experience, caste, community, EWS, PWBD etc, he will be disqualified and will not be considered for selection. If any of the documents submitted is not in English or Hindi or Malayalam, a true translation in English duly certified by the candidate shall be attached along with such documents.
