2. Enclosed "Annexure-I" for Technical Bid Document, "Annexure-II" - Item & Quantity for Financial Bid to be submitted online in Central Public Procurement Portal (CPPP), e-Procurement portal. All quotations are to be submitted on-line. Physical bids will not be accepted. Sample requirement as per Tender Document is to be submitted physically before due date and time. Coffee Table Sample is required to be submitted physically. Bids must be submitted latest by 2:00 PM IST on 19.07.2023 through the e-procurement portal of the Government of India.
3. The Agency which is bidding shall be a Firm or a Company legally registered in India under relevant Act. The Agency must meet the eligibility criteria mentioned in the tender document while submitting the bid.
4. This work contract should be completed within the time assigned by FACT. The rates quoted will remain in force till the completion of work. No demand for revision of rate on any account shall be entertained during the contract period.
5. The Agency will neither engage any sub-contractor nor transfer the contract to any other Firm/Company in any manner. The Firm/Company shall not be permitted to transfer their rights and obligations under the contract to any other individuals/Firm/Company.
6. EMD of successful tenderer shall be retained as the security deposit for the fulfillment of terms and conditions of the contract. The EMD deposit will be refunded after submission of Performance Security by the successful bidder and EMD to the unsuccessful bidders will be returned after finalization of tender (without interest, if any). This amount will be returned after successful completion of the contract, after adjustment of dues, if any, against the Firm/Company.
