Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

### 3. **Generic**

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

### 4. **Generic**

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

### 5. **Generic**

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

### 6. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

### 7. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. The offer shall be strictly as per the technical procurement specifications CD-BP-LIFT-TPS

2. Guarantee and Free Maintenance : Supplier shall give a guarantee of atleast 12 months from date of commissioning against any design/ material/ manufacturing defects and poor workmanship. Under guarantee period supplier shall conduct periodical inspection of lift , general cleaning, milling, greasing adjustment & checking of all safety device etc. as required and rectify the complaints within 24 hours.

3. Inspection and Testing of Passenger Lift : Passenger Lift material shall be inspected at the factory as per the latest IS specification before dispatch to site and the necessary test certificate shall be furnished along with the lift. It is the responsibility of the supplier to get the Lifts inspected by Designated Inspecting Authority of the Government.

4. Delivery Period: The vendor shall submit final civil, structural & electrical drawing of lift shaft within one month from the date of issue of P.O. The vendor shall supply the materials only after 8 months from the date of issue of final civil, structural & electrical drawing of lift shaft & well. This lead period is sought for civil construction of lift shaft & well by CD Civil Department. The vendor shall complete the delivery of all materials within 10 months from the date of issuing P.O.

5. Payment Terms :

a) Supply: - 80% of supply value (limited to 70% of total value of supply + I&C) together with 100% duties and taxes shall be paid within 30 days after receipt and acceptances of items at our site. Balance will be paid after successful installation & commissioning and submission of performance bank guarantee @ 10% of total basic order value for a period of 12 months from date of successful commissioning.

b) Installation & Commissioning: 100% shall be paid after successful commissioning and against submission of above PBG.

c) CAMC charges: Payment shall be made on quarterly basis after the completion of the quarter and execution of all periodic maintenances. It is compulsory to submit the copies of reports containing details of periodical maintenance done every month with the bill. This certificate has to be signed by the Engineer-in-charge OR lift supplier may submit service reports for lift duly signed by Engineer-in-charge.

## **Disclaimer/अस्वीकरण**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
