Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

## 3. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

#### Special Terms & Conditions of Supply of cement:

1. The Annual Contract for the supply of cement (PPC) shall be valid for a period of one year from the date of GeM Contract.

2. The rates quoted shall remain firm throughout the contract period. No escalation on any account will be permitted during the validity of the annual contract.

3. The total tentative quantity of cement required under the contract is 7,500 bags of 50 Kg each. However, the actual quantity may vary based on requirements during the contract period. The consigneewise quantity may also vary accordingly.

4. During the currency of the GeM Contract, FACT, at its sole discretion, reserves the right to increase or d ecrease the contract quantity at the same rate, terms, and conditions, without assigning any reason.

5. The cement shall be supplied on a staggered basis to the respective divisions of FACT as specified in th e Delivery Orders. The delivery period for each supply shall be two weeks from the date of issue of the Deli very Order. Liquidated Damages (LD) @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period, subject to a maximum of 10% of the total contract value, shall be applicable t hereafter.

The cement (PPC) supplied shall conform to IS 1489 (Part 1), and shall be from the following shortlisted manufacturers registered with FEDO/FACT: ACC, ULTRATECH, VIKRAM, SHREE CEMENT, AMBUJA, JAYPEE C EMENT, CENTURY, JK CEMENT, ZUARI, SANKAR, COROMANDEL, MALABAR, CEMENT CORPORATION OF INDI A LIMITED, PENNA.

7. A material batch certificate shall be provided along with each supply.

8. Payment shall be made within 10 days of CRAC generation on the GeM portal against each supply.

9. FACT reserves the right to terminate the contract at any stage in case of unsatisfactory performance, no n-compliance with terms, or breach of contract, after due notice.
