1. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. - 4) IBR Certification, MTC and Hydraulic Test Certificates are required for all the Level gauges along with supply.
- 5) For items vide Material Codes 724551101 and 724551102, the process end connection shall be weldable nipples (ie. butt-welding).
- 6) All materials indicated in the drawings including RTJ gaskets shall be part of the material supply.
