**1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### **SPECIAL CONDITIONS**

1. Vendor shall guarantee pump head and capacity at rated duty point without any negative tolerance.
2. The complete pump-motor shall be guaranteed for 18 months from date of despatch or 12 months from the date of commissioning, whichever is earlier. Guarantee certificate shall be furnished along with the supply.

3. All special tools, if required for installation, operation and maintenance of the pump shall be included in the scope of supply.

4. Vendor shall submit the following documents along with the offer:

- a) Duly filled pump datasheet and motor datasheet (attached).
- b) Pump performance curve corrected to working fluid.
- c) Dimensioned GAD and cross-sectional drawing of pump.
- d) BOM clearly indicating MOC of all components.
- e) Details of coupling, coupling guard and accessories.
- f) Motor GA/ outline drawing, nameplate details, terminal connection diagram, bearing details etc. Any deviation, if any, shall be clearly indicated in the offer.

5. Impeller shall be dynamically balanced and balancing certificate shall be furnished along with the supply .

6. Vendor shall submit all drawings and documents (GAD, sectional drawings, BOM, QAP, motor details etc .) within two weeks from issue of LOI / Purchase Order and obtain approval from FACT before starting the manufacturing / fabrication activities.

7. Pre-despatch Inspection (PDI) shall be carried out by FACT / FACT authorized agency (TPI) at vendor's works before dispatch.

All testing facilities, tools, tackles and calibrated measuring instruments shall be arranged by vendor. Calibration certificates of measuring instruments shall be submitted at the time of inspection. Scope of PDI shall include but not limited to the following:

- a) Verification of material test certificates (MTC), NDT test reports, balancing certificates etc. and dimensional verification.
- b) Witnessing and verification of performance test based on performance curves and hydro test on the offered pump with suitable test motor.
- c) Witnessing of vibration and sound level test (Sound level < 85 dB).
- d) Witnessing of bearing check, clearance check and casing inspection during dismantling inspection immediately after performance test.
- e) Other tests, if required as per the attached datasheets, engineering specifications of motor and approved QAP.

Cost of PDI shall be borne by FACT.

8. Final performance test shall be conducted at FACT site after erection and commissioning, in the presence of FACT and vendor representative.

9. Three (03) copies of Operation & Maintenance manuals including GA drawing, BOM and cross sectional drawings with principal dimensions shall be supplied along with the equipment.

10. Supply shall include vertical pump with motor and all necessary accessories required for complete installation, operation and commissioning.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
