### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

### 3. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of PAN Card.

- Copy of Cancelled Cheque.

##### **SPECIAL CONDITIONS:**

i) Manufacturer's material test certificates in original / attested copy for material composition, mechanical properties and pressure test as per the applicable standard shall be furnished along with the supply. All mandatory non-destructive test's as defined in the standard should be covered by the given test certificate.

ii) Marking of pipes shall be as specified in the relevant material standard. However, the following details are to be highlighted.

a) Material

b) Manufacturing method.

c) Nominal size (in mm)



d) Schedule no. / Thickness.

iii) Third party inspection by Lloyds/TUV/BV is required and under FACT scope.

Scope of third party inspection includes but not limited to:

vii) Items are urgently required. Hence ex-stock / earliest delivery may be offered.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
