Names of candidates provisionally selected for inclusion in the Panels for **Clerk on Fixed Tenure Contract (Adhoc basis), based on the willingness** submitted by the candidates, further to the notification dt 17.11.2023, on the basis of order of merit, is notified hereunder.

1. Candidate will be eligible for engagement from this panel only to the Zonal & State Offices / ASCs for which the candidate has submitted the willingness for engagement against notification dt 17.11.2023. Such engagement will be based on existing requirements or requirements that may arise in future, if any.
2. Candidate may be engaged in any of the locations to which he/she has exercised willingness, irrespective of the order of priority indicated based on their positional seniority in the merit panel. Candidate will not be considered for engagement for a location for which he/she has not intimated willingness.
3. If a candidate, after being preferred for engagement, does not appear for PEME . does not join in any of the location(s) for which he/she had indicated willingness based on notification dt 17.11.2023, name of such candidate will be removed from this panel and the panel for Clerk on Fixed Tenure Contract (Adhoc basis) in Recruitment Notification No.10/2022.
4. Engagement from the panel will be based on requirements and subject to prevalent reservation rules and criteria given in the Notification. Engagement at any point of time will be entirely at the discretion of the Management. There is no assurance that all or any of the candidate(s) included in the panel will be engaged. Further, it will be subject to verification of documents in original such as Qualification, Age, Caste / Community, Disability, ESM etc as applicable. Originals of certificates along with other relevant documents called for shall be produced for the verification at the time of pre-employment medical examination.
5. Candidate shall submit Domicile Certificate for the State applied and Police Clearance Certificate for employment at FACT, before pre-employment medical examination or as per direction.
6. Candidates will be required to undergo pre-employment medical examination and those certified fit by the Company's Medical Officer will only be offered appointment. A candidate who is found medically unfit will not be engaged. Candidates belonging to OBC-NCL, if engaged, shall submit OBC-NCL certificate which is less than six months at the time of joining.
