INSTRUCTIONS TO BIDDERS AND TERMS AND CONDITIONS FOR DISPOSAL OF OLD AND DAMAGED FURNITURE & OTHER DAMAGED OFFICE ITEMS

1. The rates quoted shall be exclusive of all taxes and levies charged by the Govt. or any other agencies.
2. The damaged assets are available at FACT Zonal Office Vijayawada. The contact address with phone number for the above point is given in the NIT.
3. The rates quoted shall be valid for 90 days from the date of tendering. The bidder shall quote rates for all the items on “as is where is” basis. Incomplete tenders will not be entertained.
4. GST, surcharge, duties, levies etc. shall be extra and shall be applicable on the quoted rate as per the prevailing rules of the Govt.
5. The items proposed for disposal are available for inspection during the office hours from 10 am to 4 pm from Monday to Friday and 10 am to 4 pm on Saturdays except on 2nd and 4th Saturdays , Sundays and Government holidays, till the last date and time for receipt of bids.
6. The company will award Sale Order to the successful bidder (H1) determined based on the highest total amount of the quoted values for each item as per the Bid Form attached. In case of any discrepancy in the rate per item, amount for the item and TOTAL AMOUNT, the highest TOTAL AMOUNT quoted in the Bid Form or the highest TOTAL AMOUNT as calculated by FACT based on rate per item / amount quoted for the item, whichever is higher, will be considered for award of Sale Order. However, FACT reserves the right to accept or reject any or all quotations without assigning any reason what so ever. If the rates quoted for an item is same or less than the rates quoted by another bidder the sale order for the item will be issued to the bidder who has quoted the highest amount for all items put together provided that the bidder is ready to match the rate for that item with the original H1 bid for that item.
7. Successful bidder shall lift all the items in “as is where is” condition after remitting necessary payments as per Sale Order.
8. The successful bidder shall arrange the clearing of all items, loading and transportation to their location on their own. FACT will have no responsibility what so ever in this matter.
