Time extensions, Corrigendums, Addendums etc if any, will be hosted in the CPP eprocure website only and will not be published in newspapers. The bidders are requested to visit the website regularly for corrigendums, addendums, time extensions etc, if any.
- 2. All bidders shall be registered under GST and shall furnish their Registration documents along with their Part-l Technical bids. Bids of parties not registered are likely to be rejected without assigning reasons. If the bidder is not required to be registered under GST Act, ie. unregistered, then a declaration has to be given specifying that they are within the threshold limit of Rs.20 Lakhs annual turnover. Also declare that once the turnover exceeds the threshold limit, they will take registration.
