

SUPPLY OF PHOSPHORIC ACID BY ROAD

ENQUIRY NOTICE

ENQUIRY NO. MAT-RM-PA-LT-BR-2025 dated 17/06/2025

1. The Fertilisers And Chemicals Travancore Limited (FACT) is a Government of India Enterprise, engaged in the production of Nitrogenous and Phosphatic Fertilizers and trading of Fertilizers.

FACT intends to procure Phosphoric Acid solution to be delivered through trucks for the period of July 2025 to March 2026. Quantity and Delivery Schedule shall be as per para 3.0 below.

In order to meet the requirement of Phosphoric Acid, FACT proposes to enter into a contract for a period of Nine Months, with suppliers as per the details indicated in this tender enquiry. We invite your most competitive bid through on-line bidding through CPP portal, GOI (<http://eprocure.gov.in>) in two-part bid format as explained in Instructions to Bidders (Annexure-II) for the supply of Phosphoric Acid as per the details given below and as per enquiry documents attached.

We invite your most competitive offer in Two Part against open tender through e-procurement portal <https://eprocure.gov.in> as per the details given below:

2. Material: Phosphoric acid as per specification enclosed (Annexure I-A & Annexure I-B). The bidder shall give offers as per the specifications given at Annexure I-A or Annexure I-B or for both. The evaluation shall be done strictly as per the evaluation Criteria at Clause No. 5 below.

3. Quantities and Delivery Schedule:

Up to 36000 MT of Phosphoric Acid (100% P₂O₅) to be supplied by the successful bidder for a period of NINE MONTHS from the date of award of contract. Supplies shall be made by road to our plants at Cochin Division Ambalamedu and / or Udyogamandal division as per FACT's requirement for an approximate total quantity of 4000 MT (100% P₂O₅) on a monthly basis. The supply shall commence immediately after issue of our Letter of Intent (LOI)/Purchase Order (PO). Bidders shall indicate the quantity offered and the monthly delivery schedule in the Unpriced Bid Format.

Bidders are free to quote for either part quantity or full quantity. In order to meet the quantity as per the enquiry, FACT may place order on one or more bidder(s) depending on the quantity / delivery schedule offered by the bidders.

FACT retains the right to accept deviation in Quantity and Delivery Schedule at its sole discretion, in case of offers suiting our requirement are not received.

The actual quantity that can be lifted each month shall be informed by the buyer during the last week of the previous month and the same shall be binding for both the parties. However, any re-appropriation of the monthly quantity within the quarter shall be done based on the mutual agreement of the buyer and the seller. If the seller is unable to supply mutually agreed quantity within the quarter, FACT reserves the right to arrange the cargo from alternate sources at the risk and cost of the seller.

During the period of agreement, FACT reserves the right to procure phosphoric acid from any other sources of its choice. The supplier has no claim whatsoever thereof.

4. Price: Price offered shall be on 100% P2O5 basis

Pricing shall be based on the formula below:

The Final Applicable Price of Phosphoric acid for the supply in a Quarter shall be the Final Basic Price applicable for the Quarter +/- α , per MT of P2O5 on Door Delivery Basis, which includes Freight and Insurance.

(a) Final Basic Price shall be the lowest CFR India Price (in USD per MT of P2O5) of Phosphoric acid reported in Argus Phosphates for the quarter in which the invoice is generated.

(b) " α " is the Premium or Discount quoted in the Priced bid in the tender and shall be held firm during the period of contract.

(c) The Quarters in a year are:

Q1: January – March

Q2: April – June

Q3: July – September

Q4: October – December

(d) The date of dispatch will be the date of invoice.

Important Note: The offered rates shall be inclusive of 30 day's credit – FOR Udyogamandal / Ambalamedu, Cochin. " α " (Premium or Discount) shall be quoted in the price bid attached with the tender documents (Annexures – V), if any.

GST will be paid, subject to the Seller meeting all the statutory requirements under the GST laws and rules to enable FACT avail Input Tax Credit.

5. Evaluation shall be done (100% P2O5 basis) on Door delivery price with 30 day's credit offered. The L-1 shall be evaluated based on USD 1153 + / - α (USD 1153 PMT P2O5 is the provisional price which is the India price for the quarter April – June 2025 and α is offered Premium or Discount in the price bid), irrespective of the specifications mentioned at Clause 2 above. The USD 1153 + / - α shall be inclusive of FOR 30 day's credit price PMT P2O5.

Exchange Rate for conversion of price will be the RBI exchange rate on the date of opening of the tender. If the date of opening is a Bank holiday, the exchange rate of the previous Bank working day will be considered for evaluation.

6. Payment Term: Shall be as per the clause-7 of the Annexure-VI.
7. Bids submitted shall be complete giving all the requirements as per the enquiry.
8. Earnest Money Deposit (EMD): As per the clause -3 of the Annexure-II.
9. Eligibility criteria:

The Bidder shall be either:

- i) Producer: Should have production capacity of 50000 MT per annum of Phos acid (100% P2O5). Letter from competent authority shall be provided in support of the same. Or,
- ii) Trader: Should have supplied to any buyer in India at least 2000 MT of Phos Acid (100% P2O5) during any one of the preceding three years ending as on the date of bid opening.

The following relevant documents, duly attested by the Applicant's Authorized Signatory, shall be submitted in support of the above:

- a) Copy of Purchase Order(s)/Agreement(s)
- b) Copy of Invoice(s)
- c) i. Traders have to submit Letter(s) issued by the Producer's Authorized Signatory confirming to backup with respect to quality and quantity along with copy/copies of Analysis Reports showing all parameters as per specifications, duly attested by the Producer's Authorized Signatory.
ii. Producer has to furnish specifications of Phosphoric Acid produced by them on their Letter Head showing all parameters as per specifications.

Notes: All bidders shall furnish, along with their bid, Questionnaire for Bidders and Compliance statement (Annexure- III and Annexure - VII), duly filled, attaching all supporting documents as required therein.

10. The bid shall be valid for a period of 15 days from the date of opening of Part A of the bid. Bids shall be submitted on two-part basis

Seller: Shall mean Bidder on whom FACT places the Purchase order.

Contract value: Contract value shall be the total all-inclusive landed cost of the material for the quantity ordered.

2.0 Bidders shall study carefully the Enquiry Notice, Instructions to Bidders and all Terms and Conditions attached along with this enquiry. All conditions set out therein shall be binding on the bidders unless conflicting with any conditions expressly stated by FACT, while accepting any bid in the event of such acceptance.

EMD shall not carry any interest. In case the bidder who is awarded the contract so desire to adjust the EMD against Security Deposit, the same may be allowed by FACT,

based on written request. EMD of the unsuccessful bidders shall be refunded after award of the contract(s).

The EMD is exempted in the case of:

- a. Producer who have production capacity of 50000 MT per annum of Phos acid (100% P2O₅). Letter from competent authority shall be provided in support of the same.
- b. Reputed traders who have supplied a minimum Quantity of 2000 MT of Phos Acid (100% P2O₅) to FACT for at least one year in the last five years.

Bidders claiming exemption/relaxation of EMD shall provide necessary documentation for the same.

The original bid shall not be withdrawn within the validity period even if negotiations are done or counter offer made by us. In case of withdrawal of offer within validity period EMD shall be forfeited. For the EMD Exempted bidders, the exemption for the next three years shall be withdrawn.

4.0 Bid documents shall consist of 2 parts, Part -A and Part- B as detailed below

PART -A: Eligibility criteria cum techno-commercial bid shall consist of the following documents.

PART B: PRICE BID; Price shall be indicated in the BOQ format.

- I. Price Bid (BOQ) attached to the enquiry shall be uploaded after filling all relevant information such as, name of the bidder, basic price, taxes & duties as called for.
- II. The priced bid shall be uploaded strictly in the format attached, failing which the offer is liable to be rejected. Renaming or changing format of the bid sheet will not be accepted by the System.
- III. Please fill-in all the relevant fields. Blank fields in the uploaded BoQ shall be taken as that particular tax / duty / charge is not applicable or as included in the basic price. No claim afterwards will be entertained.
- IV. Prices shall be quoted only in the prescribed bid form and those indicated elsewhere, if any, shall not be considered.
- V. Bidders shall quote the unit prices in figures strictly in the order of serial numbers and units as per the Price Bid. The rates of all applicable taxes/duties shall be clearly

indicated. The prices shall be firm without any escalation on any account till the order is completely executed.

- 5.0 Part-A of the bids of all bidders who submit their Bid as per the instructions by the due date and time as above and which are in conformity with the instructions specified in the enquiry documents shall be opened online.

Part -B (price bids) bids of bidders whose part-A bids are found acceptable on evaluation only, will be opened on a subsequent date.

- 6.0 Offers against this enquiry shall be submitted online on e-procurement portal <https://eprocure.gov.in>, with valid 'Digital Signature Certificate' (DSC). Offers submitted on any other platform or in any other mode including e-mails, typed/printed offers as hard copy etc. SHALL NOT be accepted.

Bidders are requested to visit Central Public Procurement Portal (<https://eprocure.gov.in>) for any updates / corrigenda on the enquiry, including extension of due date, if any. No advertisement will be given in the print media. Bidders shall meet all expenses in connection with submission of his bid, attending the bid.

Submission of the bid implies that (a) all the terms and conditions of FACT have been carefully read and understood by the bidder and (b) all the clarifications required are obtained by the bidder from FACT.

- 7.0 Bids shall be complete giving all the requirements as per the enquiry. Evaluation of bids shall be made based on the details given in the bid. Post-bid clarifications on price, quantity, delivery schedule and payment terms are unacceptable except against any post bid clarification as required by FACT. Post bid clarifications on suo-motu basis will be summarily rejected and such action by bidders will be viewed seriously.

- 8.0 The bid shall be signed by authorized persons only.

- 9.0 The original bid shall not be withdrawn within the validity period even if negotiations are done or counter offer made by us.

- 10.0 FACT is not bound to accept the lowest bid and reserves the right to reject any or all the bids without assigning any reason(s) whatsoever. FACT also reserves the right to place order/ orders on one or more bidders or cancel this enquiry.

- 11.0 FACT reserves the right to extend without giving any reason(s) the closing date/time of the enquiry.

FACT reserves the right to allow Purchase Preference to bidders as admissible under the existing Government Policy/rules.

- a. All interested bidders are requested to register themselves on the CPP with their valid DSC. TERMS AND CONDITIONS FOR PURCHASE

1. Product: Phosphoric acid as per specification attached.
2. Quantity: Quantity shall be as per weight determined basis of buyer's weigh bridge.
Note: Shortage of more than 0.5% in weight per tanker determined at FACT the entire claim of shortage will be borne by the seller. The same shall be deducted from the payment to be made to seller.
3. Quality: Determination of the quality shall be based on the analysis done at buyer's end.
Bidder shall guarantee the minimum P2O5 content in the Phosphoric Acid offered by them. If the analysis report of the sample of each tanker taken at FACT shows P2O5 content less than 0.25% of the P2O5 content of the analysis report submitted by the seller, the same shall be deducted on pro-rata basis from the payment to be made to seller.
4. Insurance: To be arranged by Seller.
5. GST will be extra as applicable.
6. Security Deposit: The successful bidder shall be required to submit Security Deposit (SD) equivalent to 2% of the order value for the faithful performance of the contract. The SD shall be submitted by way of Bank guarantee (BG) in the prescribed form as per Annexure-VIII of the enquiry documents. The list of banks from which the BG is to be obtained is enclosed as Annexure - IX of the enquiry documents.

- b. Reputed traders who have supplied a minimum of 2000 MT Phosphoric Acid (100% P2O5) to FACT during any one of the preceding three years as on the due date for submission of offer. Bidder shall be required to furnish documentary evidence such as Order copy/Invoice copy in support of the same.

The bank Guarantee shall be valid till the expiry of the contract with a claim period of three months thereafter. Validity shall be further extended on demand as per terms of our BG Proforma. Security Deposit shall not carry any interest

7. Payment Terms: Payment shall be by TT/RTGS, after receipt and acceptance of the material at FACT after expiry of the credit period of 30 days from date of Invoice.

Payment for the supplies from 1st to 15th of the month shall be made on 7th of the next month. Payment for the supplies from 16th to 30th (or 31st as applicable) of the month shall be made on 22nd of the next month. If the payment day falls on the holiday payment shall be made on the next working day.

The Exchange rate for conversion of price shall be the RBI exchange rate on the date of Payment

Supplier shall provide GST Invoice and upload the Invoice in the system and ensure filing of return enabling FACT to avail input tax credit. In case of reasons that attributable to supplier FACT is not able to avail input tax credit the next payment will be restricted to that extent.

In case India price for a quarter is not finalized prior to invoice generation, provisional invoice shall be raised with price applicable to the previous quarter.

The difference between final applicable price and payment price shall be settled within 30 days from date of final basic price is known (i.e date on which the final India price for the quarter is published in FMB) through debit/credit notes.

(The supplier has to submit the provisional invoice for the payment with provisional price with 30 day's free credit from the date of Invoice and the supplier has to submit the final invoice / debit / credit notes based on the Final applicable price).

8. Force Majeure

- i. Neither the PURCHASER nor the SELLER hereto shall be held responsible for any delay or failure to perform any or all the obligations under ORDER caused by Force Majeure. In such a case the time for performance or such obligations and the obligations of the other party to the extent that they are affected by such occurrence will be extended by such period as is duly justified. Notification of a circumstance of Force Majeure shall be given by e-mail addressed to the other party within five (5) working days of its occurrence. This notice of Force Majeure shall be confirmed by a Registered letter despatched within one (1) week, along with appropriate documentary evidence confirming the existence of a situation of Force Majeure.
- ii. For the purposes of this clause, Force Majeure means
 - a. War or hostilities
 - b. Riot or civil commotion.
 - c. Earthquake, flood, tempest, lightning or other natural calamities, epidemics.
 - d. Accident, fire or explosion not caused by willful negligence of Seller.
 - e. Labour strikes or lockout exceeding ten (10) days in duration not caused by any deliberate act or indiscretion by Seller.
 - f. Law and Order Proclamation

iii. However, should such a delay, even if due to reason of Force Majeure be protracted for more than one (1) month, FACT shall have the right to cancel ORDER at no charge to FACT and FACT shall be entitled to the reimbursement of any amount already paid to the Seller.

9. Default: In the event of any default by the Seller in executing the Purchase Order in accordance with the specifications and/or terms and conditions of the Purchase Order, FACT may terminate the Purchase Order without prejudice to any other right, remedy or option FACT may have. In the event of such termination, FACT shall have the right to procure the goods from other sources at the risk and cost of the Seller.
10. Law: In case of an Order the governing law shall be Indian Law. The language shall be English. The Seller agrees to submit himself to the jurisdiction of Indian Courts of Law.
11. Seller warrants that the goods are free and clear of liens and encumbrances and that he has good and marketable title to the same.
- 12.1 Arbitration Clause: If the Seller is a Central Public Sector Enterprise / Central Government Department: In the event of any dispute or difference relating to the interpretation and application of the provisions of this contract, such dispute/ difference shall be taken up by either Party for resolution through AMRCD as mentioned in DPE OM No.4(1)2013-PE(GM)/FTS-1835 dated 22.05.2018
- 12.2 For contracts with Indian vendors other than those mentioned in 12.1 above:
- If any dispute arises out of or relating to or in connection with this contract, between the Seller and FACT, the same shall be amicably settled through mutual discussions, failing which, the unresolved dispute(s) shall be referred to arbitration in accordance with the provisions of the Arbitration and Conciliation Act, 1996, as amended from time to time and number of Arbitrators shall be one. The venue of the Arbitration shall be at Ernakulam and the proceedings shall be in ENGLISH. Between

The Fertilizers and Chemicals Travancore Limited (FACT), a company formed and registered under the Travancore Companies Act IX to 1114 (Companies Act, 2013) and having its registered office at Eloor, Udyogamandal-683501, Kochi, Ernakulam District, Kerala, hereinafter referred to as "The Principal".

And

..... hereinafter referred to as "The Bidder/ Contractor".

Preamble

The Principal intends to award, under laid down organization procedures, contract/s for The Principal values full compliance with all relevant laws and regulations, and the principles of economic use of resources, and of fairness / transparency in its relations with its Bidder(s) and or/Contractor(s).

In order to achieve these goals, the Principal will appoint an Internal External Monitor (EIM), who will monitor the tender process and execution of the contract for compliance with the principle mentioned above.

Section 1 - Commitments of the Principal

(1) The Principal commits itself to take all measures necessary to prevent corruption and to observe the following principles:

- a) No employee of the Principal, personally or through family members, will in connection with the tender, or the execution of the contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
- b) The Principal will, during the tender process, treat all Bidder(s) with equity and reason. The Principal will in particular, before and during the tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential/ additional information through which the Bidder(s) could obtain an advantage in relation to the tender process or the contract execution.
- c) The Principal will exclude from the process all known prejudiced/interested persons.

(2) If the Principal obtains information on the conduct of any of its employees which is a criminal offence under the India Penal Code / Prevention of Corruption Act, or if there be a substantive suspicion in this regard, the Principal will inform the Vigilance Officer and in addition can initiate disciplinary actions.

Section 2 - Commitments of the Bidder(s) / Contractor(s)

1) The Bidder(s) / Contractor(s) commits themselves to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the tender process and during the contract execution.

a) The Bidder(s) / Contractor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal's employees involved in the tender process or the execution of the contract or to any third person, any material or immaterial benefit which he/she is not legally entitled to, in order to obtain in exchange, any advantage of any kind whatsoever during the tender process or during the execution of the contract.

b) The Bidder(s) / Contractor(s) will not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.

c) The Bidder(s) / Contractor(s) will not commit any offence under the relevant IPC/PC Act; further the Bidder(s)/ Contractor (s) will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.

d) The Bidder(s) / Contractor(s) of foreign origin shall disclose the name and address of the Agents / Representatives in India, if any. Similarly, The Bidder(s) / Contractor(s) of Indian Nationality shall furnish the name and address of the foreign principals, if any. All the payments made to the India agent/representative have to be in Indian rupees only.

e) The Bidder(s) / Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to, or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.

(2) The Bidder(s) / Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.

Section 3 - Disqualification from tender process and exclusion from future contracts

If the Bidder(s)/Contractor(s), before award or during the execution of has committed a transgression through a violation of Section above or in any other form such as to put his reliability or credibility in question, the Principal is entitled to disqualify the Bidder(s)/ Contractor(s) from the tender process or to terminate the contract, if already signed, for such reason.

Section 4 - Compensation for Damages

(1) If the Principal has disqualified the Bidder(s) from the tender process prior to the award according to Section 3, the Principal is entitled to demand and recover the damages equivalent to Earnest Money Deposit/Bid Security.

(2) If the Principal has terminated the contract according to Section 3, or if the Principal is

entitled to terminate the contract according to Section 3, the Principal shall be entitled to demand and recover from the Contractor liquidated damages of the contract value or the amount equivalent to Performance Bank Guarantee.

Section 5 - Previous Transgression

(1) The Bidder declares that no previous transgression occurred in the last 3 years with any other Company in India conforming to the anti-corruption approach including Public Sector Enterprise in India that could justify his exclusion from the tender process.

(2) If the Bidder makes incorrect statement on this subject, he can be disqualified from the tender process and appropriate action can be taken including termination of contract, if already awarded, for such reason.

(2) The Principal will enter into agreements with identical conditions as this one with all Bidders, Contractors/Suppliers and Subcontractors.

(3) The Principal will disqualify from the tender process all Bidders who do not sign this Pact or violate its provisions.

Section 7 – Criminal charges against violating Bidder(s) / Contractor(s)/Subcontractor(s)

If the Principal obtains knowledge of conduct of a Bidder, Contractor or Subcontractor, or of an employee or a representative or an associate of a Bidder, Contractor, or Subcontractor which constitutes corruption, or if the Principal has substantive suspicion in this regard, the Principal will inform the same to the Chief Vigilance Officer.

Section 8 - Independent External Monitor/Monitors

(1) The Principal appoints competent and credible Independent External Monitor for this Pact. The task of the Monitor is to review independently and objectively, whether and to what extent the parties comply with the obligations under this agreement.

(2) The Monitor is not subject to instructions by the representatives of the parties and performs his functions neutrally and independently. It will be obligatory for him to treat the obligations and document of the Bidder(s)/Contractor(s) as confidential. He reports to the Chairperson and managing Director, FACT.

(3) The Bidder(s)/Contractor(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the Principal including that provided by the Contractor. The Contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to this project documentation. The same is applicable to Subcontractors. The Monitor is under contractual obligation to treat the information and documents of the Bidder(s)/Contractor(s)/ Subcontractor(s) with

confidentially.

(4) The Principal will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the Principal and the Contractor. The parties offer to the Monitor the option to participate in such meetings.

(5) As soon as the Monitor notices, or believes to notice, a violation of this agreement, he will so inform the Management of the Principal and request the Management to discontinue or to take corrective action, or to take other relevant action. The Monitor can in this regard submit non-binding recommendation. Beyond this, the Monitor has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action.

(6) The Monitor will submit a written report to the Chairman and Managing Director, FACT within 8 to 10 weeks from the date of reference or intimation to him by the Principal and, should the occasion arise, submit proposals for correcting problematic situations.

(7) Monitor shall be entitled to compensation on the same terms as being extended to /provided to Independent Director on FACT Board.

(8) If the Monitor has reported to the Chairman and Managing Director, FACT, a substantiated suspicion of an offence under relevant IPC/PC Act, and the Chairman and Managing Director, FACT has not, within reasonable time, taken visible action to proceed against such offence or reported it to the Chief Vigilance Officer, the Monitor may also transmit this information directly to the Central Vigilance Commissioner.

(9) The word 'Monitor' would include both singular and plural.

Section 9 - Pact Duration

This Pact begins when both parties have legally signed it. It expires for the Contractor 12 months after the last payment under the contract, and for all other Bidders 6 months after the contract has been awarded.

If any claim is made / lodged during this time, the same shall be binding and continue to be valid despite the lapse of this pact as specified above, unless it is discharged / determined by the Chairman and Managing Director, FACT

Section 10 - Other provisions

(1) This agreement is subject to Indian Law. Place of performance and jurisdiction is the Registered Office of the Principal, i.e. Udyogamandal, Kerala.

(2) Changes and supplements as well as termination notices need to be made in writing. Side agreements have not been made.

(3) If the Contractor is a partnership or a consortium, this agreement must be signed by all partners or consortium members.

(4) Should one or several provisions of this agreement turn out to be invalid, the remainder of this agreement remains valid. In this case, the parties will strive to come to an agreement

to their original intentions.

(5) The Bidder / Contractor signing this “Integrity Pact” shall not approach the court while representing the matters to IEMs and he/she shall wait their decisions in this matter.
