10. The location of the dealer points and size specifications of the FAÇADE (Board) will be provided by the company with contact details of the retailers.
11. The standard quality and installation should be used for making the FACADE (Board)
12. **The FAÇADE (Board)** should be exactly in the size and specifications provided by the Company (The FACT Ltd).



13. The rates quoted by the successful bidder / Vendor is inclusive of all expenses to the transportation of FAÇADE (Board) and installation of the same at the specified retail counters in Thiruvananthapuram and Alappuzha districts.

14. The item of work includes the preliminary visit to the retail shops and taking measurements of the fitting size of PMKSK Façade banner & frame at the entrance of the shop, preparation of PMKSK Banner design for retailer (as per the standard design) and getting confirmation by the company officials before printing, transportation of the façade banner to the retail shops and erection, taking photos for proof of erection in Latitude & longitude photo app and submitting photos as the soft copy by what's app and mail to the company officials.

15. The successful bidder/Vendor should complete the work allotted as per the local requirement within the stipulated time and complete the work allotted within 3 months from the date of order given.

16. On completion of the work the contractor should submit the bills in duplicate. The contractor bills should accompany soft copy of the photograph of the work and a certificate from the concerned field officer of the company stating that the work has been completed as per the company's specification and to the satisfaction of the company.
