One work for pumps as above, costing not less than Rs. 12,00,000 /- b. Two works for pumps as above, each costing not less than Rs. 7,50,000/- c. Three works for pumps as above,,each costing not less than Rs. 6,00,000/-	Copies of relevant purchase order/ work orders executed along with Copies of tax invoices or completion certificates from clients shall be submitted.	
3	The bidder shall have supplied atleast one diaphragm type glandless pump having minimum 1850 LPH capacity at minimum 17Kg/cm ² discharge pressure to private/ semi govt/ state/central Govt. undertakings/ companies during the last 10 years.	Self-attested copy of purchase orders with performance certificate/ commissioning report from end user shall be submitted.	
4	a) Bidder should have achieved an average annual turnover of INR 30 lakhs during the last three financial years ending on 31-03-2021 AND b) Annual turnover for each year shall be minimum of INR 4.5 lakhs or above during the last three financial years ending on 31-03-2021	Copies of the balance sheet and profit &loss account for the last three financial years ending 31-03-2021.
