3	<p><b><u>For Rainwater pit pump:-</u></b> The bidder should be an OEM/ Authorized supplier/ distributor and should have manufactured/ supplied at least 1 no of horizontal centrifugal pump with rated motor power of 1.5KW or above and with material of construction CD4MCu/ equivalent duplex SS(wetted parts) during last 7 years ending 31.3.2021 which should be in operation rendering satisfactory performance.</p>	<p>Satisfactory performance certificates shall be submitted from the end users including private/ semi govt /state/ central govt undertakings/companies.</p>	
4	<p>a) Bidder should have achieved an average annual turnover of INR 74 lakhs during the last three financial years ending on 31-03-2020 AND b) Annual turnover for each year shall be minimum of INR 12 lakhs or above during the last three financial years ending on 31-03-2020</p>	<p>Audited Copies of the balance sheet and profit &amp; loss account for the last three financial years ending on 31-03-2020.</p>
