2	<p>The bidder shall have successfully executed orders for supply of Gas Analysers during the last five years ending on the date of Enquiry.</p> <p>The offered analyser make & type shall be in operation in India satisfactorily for a continuous period of three months in any application in Fertilizer/ chemical/ Pharma/ power/ Refinery/ petrochemical/ metallurgy/ Boiler plants within 36 months ending as on date of NIT.</p>	<p>Copies of relevant purchase order/ work orders along with respective completion certificate/ delivery challan/ relevant document to prove successful completion of the order.</p> <p>a) Copy of purchase/ work order and</p> <p>i) Analyser performance report or certificate or</p> <p>ii) Minutes of Meeting or</p> <p>iii) feedback from end user</p> <p>In case of Minutes of meeting or feedback from the end user is submitted, it shall clearly indicate make, type and analyser performance.</p>	
3	<p>a) Bidder should have achieved an average annual turnover of INR 28 lakhs during the last three financial years ending on 31-03-2019</p> <p style="text-align: center;">AND</p> <p>b) Annual turnover for each year shall be minimum of INR 4.7 lakhs or above during the last three financial years ending on 31-03-2019</p>	<p>Copies of the balance sheet and profit & loss account for the last three financial years ending 31-03-2019.</p>
