4	a) Average annual turnover of the bidder for the last three financial years ending on 31-03-2021 shall be Rs 30 lakhs or above And b) Minimum annual turnover for each year shall be Rs. 4.5 lakhs during the last three financial years ending on 31-03-2021	Copies of audited financial statements (Profit & Loss Account and Balance Sheet) for the last three financial years ending on 31-03-2021 (2018-19, 2019-20 & 2020-21)	Relevant documents required
