2	The bidder shall have successfully completed Purchase/ work orders as per any one of the three conditions given below for supply of <u>low voltage switch gears</u> * during the last 7 years in any Industrial/commercial establishments as on the final due date of the submission of technical bid. a. One work of similar nature as per the scope of work, costing not less than Rs. 9,00,000 /- b. Two works of similar nature as per the scope of work, costing not less than Rs. 6,00,000/- c. Three works of similar nature as per scope of work,each costing not less than Rs. 5,00,000/-	1. Copies of relevant purchase order/ work orders executed in the last 7 years along with Copies of tax invoices or completion certificates from clients 2. copies of satisfactory performance certificates from clients 3. List of customers for whom similar kind of equipment were supplied along with the details of contact person, mobile No, landline no., Fax, email address.	
3	a) Bidder should have achieved an average annual turnover of INR 22 lakhs during the last three financial years ending on 31-03-2020 AND b) Annual turnover for each year shall be minimum of INR 3.7 lakhs or above during the last three financial years ending on 31-03-2020	Copies of the balance sheet and profit &loss account for the last three financial years ending 31-03-2020.	

Note: * low voltage switchgears : rated voltage of which does not exceed 1000 V a.c. at frequencies not exceeding 1000 Hz.

2. Pre-Qualified bids will only be considered for Technical Evaluation. Technically and Commercially Acceptable Bids will only be considered for Price Bid opening.
