# TERMS AND CONDITIONS OF CONTRACT INSTALLATION OF FLEX SIGN BOARDS IN DEALERS SHOP UNDER PMKSK SCHEME IN BELGAUM ZONE OF KARNATAKA

#### 1 DEFINITIONS

- 1(a) FACT shall mean THE FERTILISERS AND CHEMICALS TRAVANCORE LIMITED with Registered office at Udyogamandal, Kochi-683501, its operating Divisions at Udyogamandal (FACT-UD) and at Ambalamedu (FACT- CD) and Marketing offices spread across South India (which expression shall repugnant to the context or meaning thereof, include its successors and assigns).
- 1(b) "Contractor" shall mean the individual / firm / company, who has been awarded the Work Order (contract) against his/their bid in response to the enquiry issued by FACT and shall include his/their legal representatives heirs, successors and assigns.

#### PERIOD OF CONTRACT

The period of Contract shall be for a period of 6 months from the date of issue of Work order.

The quotatiopns should reach the State Office located in Bangalore: No 150, 18<sup>th</sup> Cross, CHBCS Layoput, Vijayanagar Bangalore-560040 on or before 03.00 pm on 06.03.2023.

The quotations received after the stipulated time and date will not be entertained

#### 3. EMD

The tenderer shall provide Earnest Money Deposit (EMD) of Rs.5000/- (Rupees Five thousand only) by RTGS to FACT LIMITED through SBI, Udyogamandal Branch, Account Number 57017844467, IFSC SBIN0070158.

- 4. FIRMNESS OF RATES AND RIGHT OF ACCEPTING AND REJECTING TENDER DOCUMENTS.
- 4.1 The rates shall be firm throughout the contract period. No charge/claim on any account, incidental or otherwise, other than expressly provided in the contract, shall be payable by FACT.
- 4.2 The company reserves the right to accept or reject any or all quotations without assigning any reason what so ever.
- 4.3 Incomplete tender documents will be rejected.
- 5. QUANTUM OF WORK:

The work involves installation of 137 boards in the districts mentioned above. The tentative list of dealers is furnished as Annexure. However, the list is indicative and subject to change depending on Company requirement. FACT reserves the right to reduce or increase the quantum of work at any time without assigning any reason whatsoever and the contractor shall carry out the work as per actual quantity requirements of FACT at the same rates and terms & conditions as per the W.O. The contractor has no right to claim loss / loss of profit on account of reduction in revenue arising out of variation in quantum of work.

## 6. Goods and Service Tax(GST)

Rates given in the Work Order are exclusive of Goods and Service Tax (GST) and the contractor or FACT, as the case maybe, shall remit GST incompliance with the statute. Incase GST has to be paid by the contractor as per relevant Rules & Regulations the same shall be reimbursed to the contractor against documentary proof.

The bidder shall furnish the following along with the offers.

- 1. The GST registration Number and details. In the case of Provisional ID, GST Registration Number shall be provided on receipt of the same.
- 2. Place of supply/Service
- 3. Address of the supplier / service provider's billing the item if it is different from 2 above
- 4. GST rates applicable for each item

In case of unregistered contractor, a declaration to that effect with

reason should be furnished.

FACT's GST No in the state of Karnataka is 29AAACT6204C1ZP.

The supplier/contractor shall do the following:

- a) Submit GST compliant tax invoice to FACT along with supply.
- b) Shall ensure uploading the above invoice as per statute&
- c) File monthly returns in time enabling FACT to claim the input tax credit.

GST charged by the supplier/contractor shall be released separately to the supplier/contractor only after filing of (i) the outward supply details & the monthly return on GSTN portal by the supplier/contractor and (ii) on matching the input tax credit to such invoice with the corresponding details of outward supply of the supplier/contractor.

In case FACT incurs any liability (like interest, penalty etc.,) due to denial/reversal of such input tax credit in respect of the invoice submitted by the supplier/contractor, for the reasons attributable to the supplier/contractor, the same shall be recovered from the supplier/contractor

Further in case FACT is deprived of the input tax credit due to any reason attributable to the supplier/contractor, the same shall not be paid or recovered if already paid to the supplier/contractor.

### 7. SCOPE OF WORK.

7.1 Sign board shall be prepared as per dimensions provided by concern Sales Officer. Tentative list of dealers is as per Annexure I (List is subject to change as per company requirements).

- 7.2 The design for the board shall be given by FACT/ Contractor need to edit only name and address of the dealer for each board as per the details given by FACT
- 7.3 Specifications for flex board are 0.75" 21 Gaze MS Square Pipe, with Star Black back Print (Star Flex).
- 7.4 Work should be completed within 30 days from Date of issue of Work order in coordination with concerned officer.
- 7.5 Design editing in given design, Printing, Board Preparation Transportation and Installation of Board is to be done by Contractor only.
- 7.6 Contractor should provide Soft and Hard copy of GPS (With longitude and Latitude) Photos of work done.
- 7.7 The contractor shall carry out all works incidental to the scope of work stated above, whether expressly mentioned herein or not, for executing the contract to the satisfaction of FACT. FACT will not be responsible for any damage of board during transportation and fixing.

#### **PAYMENT**

- 9.1 Payment for the work done as per this contract shall be effected on presentation of the bills to the ZM of the respective Zonal Office of FACT, duly certified by the Dy. M (S)/SO concerned. The Bills in duplicate in the prescribed proforma shall be submitted on completion of the work in a District duly supported by copies of the GPS Photos and details and sign of Dealer concerned. Payment of bills to the contractor will be made through NEFT/RTGS from the Head Office normally within 30 days from the date of submission of bills along with all supporting documents.
- 10 ALTERNATE ARRANGEMENT AT THE RISK & COSTOFCONTRACTOR

In the event of failure on the part of the contractor to execute the contract to FACT's satisfaction FACT may give notice in writing to the contractor calling him to make good the failure, neglect or contravention complained of within the said time. If the contractor still fails to make good failure as called for, FACT reserves the right to terminate the Contract in whole or part and make alternate arrangements to carry out the work through other agencies or by themselves at the risk and cost of the contractor without prejudice to FACT's other rights as per the Contract. FACT shall recover all additional costs incurred for such alternate arrangements from the contractor's running bills or from any amounts due to the contractor.

#### 11 INDEMNITY

Without prejudice to any other provisions in these conditions, the contractor shall be bound to keep FACT or any representative or employee of FACT fully indemnified against any action, claim or proceedings under the provisions of any rules, regulations, byelaws, notifications, directions or order having the force of law for anything done or omitted to be done by the contractor in contravention of such provisions etc. for the infringement or violation thereof by him in the course of the execution or completion of the work under the contract and if, as a result of any such action, claim or proceedings, the contractor or such representative of FACT, as the case may be, adjudged to be liable to any penalties or to pay any penalties or to pay any compensation, such liability, the contractor shall do so and if FACT has to take-over the liability, FACT shall deduct all amounts arising out of such liabilities

from the security deposit of the contractor or from any other amount due and payable by FACT to the contractor under this Contract or any other Contract and without prejudice to any other legal remedy available to FACT.

#### 12 ASSIGNMENT

The contractor shall not assign or transfer or sublet the contract or any part thereof without the prior written approval of FACT.

#### 13 TERMINATION OF CONTRACT

FACT at its entire discretion may terminate the contract either in part or in full after giving 7 (Seven) days' notice in writing to the contractor.
