



SPECIAL TERMS AND CONDITIONS OF PURCHASE

1. SCOPE OF WORK

The scope of work includes supply of CONTROL VALVE with accessories along with spares as per Data sheets, Technical procurement specification attached.

The shutdown valves shall be supplied as per the following documents

- a) Data sheets 32654-14-DA-00001 & 32654-14-DA-0002
- b) Control valve engineering specification: 14ES002/15 and solenoid valve engineering specification:14ES003/15
- b) Special requirement of valves: 32654-14-PS-001 SPL (INST)
- c) Items to be supplied: 32654-14-PS-001 IS
- d) Spares (Instrumentation): 32654-14-PS-001 SPR INST
- e) Vendor data submission procedure: 00ES001/03
- f) Vendor data index:32654-14-PS-001 VDI

The technical bid for the valves shall be submitted in compliance with the specification no. 03ES300/10. All relevant documents specified in the vendor data requirements (doc no. 32654-14-PS-001 VDR INST) attached with this enquiry shall be furnished progressively as applicable after the placement of purchase order

TPI agency: [is M/s Indian Register of Shipping(IRS)]. The item shall be manufactured and supplied under the inspection of our TPI agency M/s IRS as per document no. 32654-14-PS-001 SIT INST (Scope of inspection and tests) and the test certificates endorsed by the agency shall be furnished.

The items are to be used for Ammonia service, which is critical item in process and safety parameters.

2. SITE

Delivery of the item is required at FACT ENGINEERING WORKS, Palluruthy, Cochin.

3. TERMS OF PAYMENT:

Supply: 100% of the supply value including spares will be paid within 30 days after receipt and acceptance of the supplies at site & PBG.

4. SECURITY DEPOSIT:

The Bidder shall, within 15 days of receipt of order, furnish towards security for faithful performance of ORDER a cash deposit or a Bank Guarantee for a value equal to 3% of the ORDER Value in the Proforma attached and shall be issued / confirmed by a nationalized/scheduled Bank in India..

5. GUARANTEE / PERFORMANCE BANK GUARANTEE(PBG):

The vendor shall provide guarantee for the entire supply and accessories, for a period of 12 month from the date of commissioning or 18 months from date of dispatch, whichever is earlier. PBG for 10% of the total order value valid for the entire warranty period with 6 months claim period as per proforma attached shall be furnished along with supply.

6. EVALUATION OF PRICES & LOADING:

The total cost for supply(& spares) for all valves, along with applicable P&F, freight charges, loadings if any, etc. will be evaluated to arrive at the lowest offer and order will be placed on the lowest bidder(among the prequalified technically acceptable offers).

7. TEST CERTIFICATES:

Test certificates as per technical procurement specification shall be submitted along with the supply

8. BID SECURITY DECLARATION:

Bids must be supported by a Bid Security Declaration in lieu of Earnest Money Deposit. Only those bids accompanied by bid security declaration shall be considered for evaluation.



9. DELIVERY PERIOD:

Item shall be supplied within 5-8 weeks from the date of receipt of order.

10. ORDER OF PRECEDENCE:

In the event of any conflict between this Special Terms & Conditions and the Terms and Conditions mentioned elsewhere in the enquiry document, the former shall prevail to the extent applicable.
