

### SPECIAL TERMS AND CONDITIONS OF PURCHASE

ENQUIRY No. MM/175/E26156 Dt. 15-09-2022

### **1. SCOPE OF WORK**

The scope of work includes supply of Hydraulic Diaphragm Reciprocating Pump Assembly along with spares as per Data sheets, Technical procurement specification attached.

## 2. SITE

Delivery of the item is required at FACT UDYOGMANDAL division, Cochin

# 3. TERMS OF PAYMENT:

100% of the supply value will be paid within 30 days after receipt and acceptance of the supplies at site and against 10% Performance Bank Guarantee.

# 4. Earnest Money Deposit:

Earnest Money Deposit of Rs. 37,500/- shall be submitted along with the bid through RTGS/NEFT. EMD will be exempted for Govt. firms/public sector units/firms registered under NSIC/MSME/Khadi Board etc. on submission of valid documentary evidence as per Govt. guidelines.

# 5. SECURITY DEPOSIT:

The Bidder shall, within 15 days of receipt of order, furnish towards security for faithful performance of ORDER a cash deposit or a Bank Guarantee for a value equal to 3% of the ORDER Value in the Proforma attached and shall be issued / confirmed by a nationalized/scheduled Bank in India.

# 6. **GUARANTEE:**

The vendor shall provide guarantee for the entire supply and accessories, for a period of 12 months from the date of commissioning or 18 months from date of dispatch, whichever is earlier.

# 7. PERFORMANCE BANK GUARANTEE:

Bidder shall submit Performance Bank Guarantee (PBG) for an amount equivalent to 10% of the total order value as per the relevant formats attached and shall be issued/ confirmed by a nationalized/scheduled Bank in India.

### 8. EVALUATION OF PRICES & LOADING:

The total cost for supply (including spares) along with applicable P&F, freight charges, loadings if any, etc. will be evaluated to arrive at the lowest offer and order will be placed on the lowest bidder. (among the prequalified technically acceptable offers). Ordering of spares shall be at FACT's discretion.

### 9. PRE DISPATCH INSPECTION:

Pre dispatch inspection will be conducted at vendor's work by FACT personnel. Scope of PDI includes verification/ Review of Material Test Certificates, Hydro test certificate etc. and witnessing the performance test of the pump.

### **10.TEST CERTIFICATES:**

Test certificates as per technical procurement specification such as Material test certificates, Hydro test certificates, performance test report of the pump, operation and maintenance manual with cross sectional GA drawings, relevant Motor test certificates and operation & Maintenance manual shall be submitted.

### **11. ORDER OF PRECEDENCE:**

In the event of any conflict between this Special Terms & Conditions and the Terms and Conditions mentioned elsewhere in the enquiry document, the former shall prevail to the extent applicable.
