

INSTRUCTIONS TO BIDDERS & TERMS AND CONDITIONS FOR DISPOSAL OF NON STANDARD FERTILIZER AAVAILABLE AT CHINGAVANAM RMC, KOTTAYAM

- 01. The rates quoted shall be exclusive of all taxes and levies charged by the Govt. or any other agencies.
- 02. Bidders should be manufacturers of fertilizer mixtures or Govt. Research Farms or Universities or such bodies as per sub clause 23 of the FCO 1985
- 03. The non standard fertilizers are available at FACT Regional Mixing Centre, Chingavanam, Kottayam-686531. Ph.0481-2430345
- 04. The rates quoted shall be valid for 90 days from the date of tendering. The bidder shall quote rates for all the items on "as is where is" basis. Incomplete tenders will not be entertained.
- 05. Price should be quoted as Rs. Per MT basis.
- 06. GST, surcharge, duties, levies etc. shall be extra and shall be applicable on the quoted rate as per the prevailing rules of the Govt.
- 07. The items proposed for disposal are available for inspection by the bidders at RMC Chingavanam during the office hours from 10 AM to 4 PM on all working days except Sundays and Holidays, till the last date and time for receipt of bids.
- 08. Sale order will be raised to individual line item on the basis of highest rate quoted not aggregate value. In case more than one bidder qualified as H1 the quantity will be equally divided among the successful bidders.
- 09. Successful bidder shall lift all the items in "as is where is" condition after remitting necessary payments as per Sale Order.
- 10. The successful bidder shall arrange the clearing of all items, loading and transportation to their location on their own. FACT will have no responsibility what so ever in this matter.
- 11. The successful bidder shall arrange the labourers and means of transport to clear the entire lot of fertilizer as per the sale order

- 12. The successful bidder shall complete the clearing work within 45 days from the date of award of Sale Order.
- 13. In the event of termination of the sale order due to any fault/failure of the successful bidder the company reserves the right to make alternate arrangements for disposal of the items and to forfeit the Earnest Money Deposit of the successful bidder.
- 14. The company further reserves the right to realize compensation from the successful bidder for additional loss if any incurred by the company as a result of the successful bidder's failure to fulfill his obligations as per the Sale Order.
