3	<ol style="list-style-type: none"> a) Bidder should have achieved an average annual turnover of INR 22 lakhs during the last three financial years ending on 31-03-2019 AND b) Annual turnover for each year shall be minimum of INR 3.7 lakhs or above during the last three financial years ending on 31-03-2019 	Copies of the balance sheet and profit & loss account for the last three financial years ending 31-03-2019.
