



SPECIAL TERMS AND CONDITIONS OF PURCHASE

ENQUIRY No.MM/175/E23809 dt.9-8-2021

1. SCOPE OF WORK

Design, manufacture, and supply of 3.3kV, 50Hz, 1600A, 31.5 KA indoor Vacuum circuit breaker switch board complete with all accessories as per the detailed specification attached.

2. SITE

Delivery of the item is required at FACT Udyogmandal Division, Ernakulam. For foreign vendors, the port of destination for shipment of goods is Kochi (Cochin) Sea Port/ Kochi Airport.

3. TERMS OF PAYMENT:

Supply:100% of the supply value will be paid within 30 days after receipt and acceptance of the supplies at site.

Supervisory charges: supervision for testing and commissioning shall be payable within 15 days of successful commissioning and take over.

4. SECURITY DEPOSIT:

The Bidder shall, within 15 days of receipt of order, furnish towards security for faithful performance of ORDER a cash deposit or a Bank Guarantee for a value equal to 3% of the ORDER Value in the Proforma attached.

5. PERIOD OF COMPLETION:

The vendor shall complete the supply within a period of 28 weeks from the date of final drawing review/ approval. The drawings for review/ approval shall be submitted within 15 days from the date of Purchase order. Revised final drawings for final approval, after incorporating all comments/ changes from purchaser, if any shall be submitted within 10 days from the date of intimation of comments/ changes in drawing from purchaser.

Vendor shall complete the testing and commissioning assistance within a period of 4 weeks from the date of work to proceed notice.

6. INSPECTION AND TESTS:

All tests specified in the scope of Inspection and Tests attached separately with the Technical procurement specification shall be performed.

7. WARRENTY:

The vendor shall provide warranty for the entire switch board and accessories, for a period of 12 months from the date of commissioning or 18 months from date of dispatch, whichever is earlier.

8. BID SECURITY DECLARATION:

Bids must be accompanied by a Duly executed Bid Security Declaration (in lieu of Earnest Money Deposit) as per proforma attached with the tender. Only those bids accompanied by bid security declaration shall be considered for evaluation.

9. EVALUATION OF PRICES & LOADING:

The total cost for supply including spares and supervisory charges with applicable P&F, freight charges, taxes, loadings if any, etc. will be evaluated to arrive at the lowest offer and order will be placed on the lowest bidder (among the prequalified technically acceptable offers).

10. INTEGRITY FACT :

Bidder shall submit the filled in & Signed Integrity Pact attached with the tender in Rs. 500/- stamp paper. A soft copy of the same shall be uploaded along with Bid and the Original shall be posted / couriered to us so as to reach by the bid opening time.



Priced Bids of bidders who do not submit the Integrity Pact shall not be considered for bid opening.
